The Data Governance Board worked to approve the first set of more than forty business terms for University-wide publication in the consolidated data dictionary in Fall 2020. The centralized documentation of PeopleSoft business terms will help a variety of data users across campus.

Along with the consolidated dictionary, Data Governance worked with Institutional Research to update and expand the definitions included in the TCU Fact Book. All of the documentation items help create a **common data language** across campus, which improves our institutional data literacy. In addition to this work, there are business-specific terms that the committees are currently working to update, which will have an institution-wide impact. News regarding these terms should be released this summer.

Common Data Language

Data literacy is essential to data-informed decision-making. "If there is no common language with which to interpret the various data sources in the organization, there will be fundamental communication challenges when using data- and analytics-based solutions" (Christy Pettey for <u>Smarter with Gartner</u>). Along with preventing communication challenges, creating a common data language and data dictionaries will help data users understand and report consistent, accurate, and timely data. The room for error in data usage and reporting decreases when data literacy increases.
